CTM 105 BLUEPRINT READING FOR CONSTRUCTION

PREREQUISITE: None

COURSE DESCRIPTION

Introduction to reading, interpretation, and visualization of blueprints in construction.

Apply basic print reading techniques in construction through applied problem solving.

- 2.4 interpret and visualize blueprints for plot plans, foundations, framing, plumbing, HVAC, electrical, masonry, welding, and details.

6. <u>STUDENT RESPONSIBILITIES</u>
