## CTM 123 BUILDING CONSTRUCTION METHODS 1

Credit Hours: 3 Lec 2 Lab 2

PREREQUISITE: None

COURSE DESCRIPTION

Floor foundations and interior/exterior framing, including various types and methods of building foundations and framing systems.

1. COURSE GOAL

Understand the various types and methods of foundation and framing construction and provide the apprentice with knowledge and experience in building various foundations and framing systems.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify all basic instruments and tools used in foundations and framing construction.
- 2.2 demonstrate the use and care of foundations and framing instruments and tools.
- 2.3 describe the various foundation and framing materials and terminology.
- 2.4 demonstrate the ability to perform basic foundation and framing construction.
- 2.5 develop a basic understanding of the various components, which interlock to create a finished structure.
- 2.6 develop a basic understanding of the structural parts required to enclose in a typical structure.

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
