# ARIZONA WESTERN COLLEGE SYLLABUS

CUL 144 MENU PLANNING Credit Hours: 1 Lec 1.5

PREREQUISITE: Current Yuma County Food Handler's card

### **COURSE DESCRIPTION**

A course designed to provide knowledge about menu planning to meet the Recommended Dietary Allowances (RDA) established by the Food and Nutrition Board of National Academy of Sciences while also considering cost, staffing and facility constraints.

## 1. COURSE GOALS

- 1.1 To provide the environment for students to develop menu-planning skills.
- 1.2 To provide opportunities for students to practice these skills.
- 1.3 To give students the tools to evaluate, adapt and merchandise menus.
- 1.4 To provide the students with practice in calculating quantities to purchase, developing production sheets, and costing menus.

- 2.1 demonstrate basic skills in menu planning.
- 2.2 apply knowledge of the U.S. Dietary Guidelines to menu planning.
- 2.3 use systematic approach in evaluating a menu.
- 2.4 adapt the basic menu to accommodate needs and likes of adults and children at various ages and stages of development, regional/ethnic preferences, and seasonal changes.
- 2.5 relate the role that menu planning plays in successful food service operations.
- devise various techniques that could be used successfully to merchandise the menus planned.
- 2.7 calculate quantities of food stuffs to purchase.
- 2.8 develop production sheets.
- 2.9 apply formulas for costing menus.
