COURSE DESCRIPTION

History and customs, serving styles and preparation techniques of cold foods with an emphasis on practical cooking experiences.

1. COURSE GOAL

- 1.1 Possess a working knowledge of cold food production
- 1.2 To know history, customs and principals involved in the preparation of cold foods.
- 1.1 To gain skill in tool, and equipment use.
- 1.2 To apply knowledge of laws and regulations relating to safety and sanitation in the kitchen.
- 1.3 To acquire a food Handles Card while enrolled in all Culinary Classes

- 2.2 utilize fundamental skills in the preparation of various types of cold food, salads, dressings, and basic garnishes
- 2.3 explain the history and influences from Regional Cuisine.
- 2.4 demonstrate a variety of styles of Garde Manger
- 2.5 use proper sanitation procedures of the Kitchen.
- 2.6 describe how each cooking style that we now use.
- 2.7 To gain skill in tool, and equipment use.
- 2.8 To apply knowledge of laws and regulations relating to safety and sanitation in the kitchen.

6. STUDENT RESPONSIBILITIES
