CUL 241 Basic Culinary Arts 2 Credit Hours: <u>3</u> Lec 1.5 Lab <u>3</u>

PREREQ: CUL 146

COURSE DESCRIPTION

Continuing basic principles of food selection and preparation in a commercial kitchen. Additional hands-on application of professional culinary skills.

1. <u>COURSE GOAL</u>

Gain basic knowledge of food selection, preparation, methods and techniques; understand the scientific principles involved in food preparation; understand the basic importance of the garde manger cold kitchen preparations with an emphasis on use of quality ingredients.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify tool and equipment used in the production kitchen
- 2.2 demonstrate quality food selection and preparation through correct techniques
- 2.3 demonstrate fundamental skills in preparing cold soups, salads, dressings, pates, terrines, sausage, cheese and appropriate garnishes
- 2.4 preparation of hot foods
- 2.5 applying recipes to practical application in a commercial kitchen

6. <u>STUDENT RESPONSIBILITIES</u>
