COURSE DESCRIPTION

Continuing history and customs, serving styles and preparation techniques of cold foods with emphasis on practical cooking experiences. Advanced garde techniques including pates, terrines, and sausages.

1. <u>COURSE GOAL</u>

Possess a working knowledge of, customs and principles involved in the preparation of cold foods, demonstrate fundamental skills in preparing cold soups, salads, dressings.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify tools and equipment used in the Production Kitchen.
- 2.2 demonstrate fundamental skills in preparing cold soups, salads, dressings pates, terrines, sausage, cheese and appropriate garnishes.
- 2.3 demonstrate quality food selection and preparation through correct techniques.
- 2.4 use proper sanitation procedures of the Production Kitchen.

6. <u>STUDENT RESPONSIBILITIES</u>
