COURSE DESCRIPTION

History and customs, serving styles and preparation techniques of foods unique to selected international cultures with emphasis on practical cooking experiences.

1. COURSE GOAL

- 1.1 Possess a working knowledge of International Cuisine including Italian, German, Oriental Middle Eastern, and Spanish.
- 1.2 To know history, customs and principals involved in the preparation of International Cuisines.
- 1.3 To correctly follow recipes according to the Countries traditions and ingredients.
- 1.4 To gain skill in tool, and equipment use.

6. STUDENT RESPONSIBILITIES
