CUL 258 Advanced Cuisine

Credit Hours: 5 Lec 1.5 Lab 7

PREREQUISITES: CUL 143, CUL 241

COURSE DESCRIPTION

Laboratory experience in applying principles of food preparation to produce a variety of food products from American, Regional, and International Cuisine for consumers as well as development of skills in knife, tool, and equipment use, cleaning and maintenance.

1. COURSE GOALS

- 1.1 To gain skill in preparing meats, seafood, poultry, soups, stocks, sauces, vegetables, starches.
- 1.2 To gain skill in knife, tool, and equipment use.
- 1.3 To apply knowledge of laws and regulations relating to safety and sanitation in the kitchen.
- 1.4 Possess a working knowledge of American, Regional, and International Cuisine including history, customs, and principles involved in the preparation of foods.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate knife, hand tool and equipment use, cleaning, and maintenance.
- 2.2 demonstrate how to read and follow a standard recipe.
- 2.3 identify and use utensils, pots and pans.
- 2.4 explain the history and influences in American, Regional, and International Cuisine.
- 2.5 utilize fundamental skills in preparation of various types of American, Regional, and International Cuisine.
- 2.6 demonstrate methods of cooking including roasting, broiling, grilling, sautéing, frying, braising, stewing.
- 2.7 identify and use herbs, spices, oils, and vinegars.
- 2.8 identify and prepare meats, seafood, and poultry.
- 2.9 identify and prepare soups, stocks, and sauces.
- 2.10 identify and prepare vegetables and starches.
- 2.11 use safety and sanitation rules in food preparation.
- 2.12 demonstrate a variety of serving styles and customs associate with the appropriate American, Regional, and International influences of each dish.
- 2.13 describe how each region, country, and culture influences the cooking style we now use.

6. STUDENT RESPONSIBILITIES
