DFT 100 AutoCAD 1 – DRAFTING

Credit Hours: 3 Lec 2 Lab 2

NOTE: CIS 102 and MAT 105 or approved higher level math recommended

COURSE DESCRIPTION

The course provides an understanding of basic drafting fundamentals, drafting standards/conventions and the methods of graphic preparation, principles of drafting and design using Computer Aided Drafting (CAD), and the role that graphic language plays in the conception/analysis for the communication of ideas for industry. This course introduces a beginning level of AutoCAD features.

1. COURSE GOAL

To learn basic drafting techniques using Computer Aided Drafting software.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 discuss the equipment, theory, drafting techniques, and related standards associated with CAD drafting.
- 2.2 demonstrate knowledge of the principles of drafting using CAD software.
- 2.3 create and develop drawings from scratch or by using standard CAD templates.
- 2.4 demonstrate technical skills to communicate CAD drafting concepts using drawing and editing commands, basic object commands, layers and drawing construction tools.
- 2.5 place text and dimensions accurately on drawings using CAD commands.
- 2.6 arrange and pattern objects on drawings using CAD commands.

6. STUDENT RESPONSIBILITIES
