## **COURSE DESCRIPTION**

Fundamentals of graphical communications, including sketching, computer-aided drafting, design, and parametric modeling.

1. <u>COURSE GOAL</u> Develop a basic knowledge of SolidWorks

Upon satisfactory completion of this course, students will be able to:

- 2.1 Define engineering graphics and explain its history.
- 2.2 Describe and show the basic parametric modeling procedure.
- 2.3 Create 2D sketches in SolidWorks using dynamic viewing commands and parametric dimensions.
- 2.4 Illustrate the different extrusion options in SolidWorks and utilize geometric relations to display and modify parametric relations.
- 2.5 Define dimensioning nomenclature and create drawing layouts from solid models.
- 2.6 Set up the tolerancing option in SolidWorks to meet ANSI and ISO standard fits.
- 2.7 Use the assembly modeling methodology to place parts using SolidWorks SmartMates.
- 2.8 Create exploded assemblies and assembly drawings in SolidWorks.

## 6. <u>STUDENT RESPONSIBILITIES</u>
