### PRE-REQUISITE: DFT 107

#### **COURSE DESCRIPTION**

A course for development of higher order skills in the use of Revit for development of Mechanical, Electrical and Plumbing drawings for building information management systems and drafting design

# 1. <u>COURSE GOAL</u>

Understand the use of Revit functions and applications as used for building modeling and building information management as it relates to mechanical, electrical and plumbing systems and installations.

#### 2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate use of Revit program functions and techniques in the production of drawings as they relate to mechanical, electrical and plumbing systems and installations.
- 2.2 develop a Revit generated modeling project utilizing Revit techniques as prescribed by the instructor to represent mechanical, electrical and plumbing systems and installations.
- 2.3 demonstrate ability to solve modeling problems related to mechanical, electrical and plumbing systems and installations with the assistance of Revit in design, and graphic representations as prescribed by the instructor.
