### **COURSE DESCRIPTION**

This course focuses on the skills that employers are seeking, including email marketing, designing, and running an online store, social media marketing, and marketing analytics. This course is Open Entry/Open Exit (OE/OE).

This course prepares learners with a basic knowledge and understanding of digital marketing and ecommerce and the how to attract and engage customers through digital marketing channels like search and email, measure marketing performance through analytics and present insights, build ecommerce stores, analyze online performance, and grow customer loyalty.

- 2.8 Learn SEM (Search Engine Marketing), how to use the tools, and run successful paid campaigns.
- 2.9 Learn SEO (Search Engine Optimization), and how to organically increase your website's ranking, and what strategies to use.
- 2.10 Explain how to set up a plan for boosting your social media reach with measurable results.
- 2.11 Understand the importance of incorporating video format marketing that is seen by the audience you are targeting.
- 2.12 Describe measure marketing performance through analytics and present insights.
- 2.13 Build e-commerce stores, analyze online performance, and grow customer loyalty

## 6. STUDENT RESPONSIBILITIES
