PREREQUISITE: DNC 071

COURSE DESCRIPTION

Exposure to the two types of Native Hawaiian Dance, *Hula*: kahiko - ancient and `auana - modern.

1. COURSE GOAL

- 1.1 Study the basics of Native Hawaiian Dance, *Hula*: terminology in `Ōlelo Hawai`i- Hawaiian language, basic steps, storytelling through body movement and introduction of *kaona* (figurative interpretation of words)
- 1.2 Exposure to `Ōlelo Hawai`i- Hawaiian language
- 1.3 Know the history and traditions of *Hula*
- 1.4 Awareness of body in space

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 Demonstrate understanding of the terminology in `Ōlelo Hawai`i- Hawaiian language for basic feet and hand movements.
- 2.2 Practice and perform the basic foot and hand movements of *Hula* within the context of a choreographed dance.
- 2.3 Describe the history of the *hula*.

4. LEARNING ACTIVITIES

- 4.1 Participation in learning basic steps and hand gestures
- 4.2 Practicing working within small and large groups
- 4.3 Document *nā mele*- songs and *nā oli*- chants along with feet and hand movements within a notebook

- 5.1 Demonstration of competencies
- 5.2 Quizzes (written and demonstrative)
- 5.3 Public Dance Performance

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 Classroom Assignments: Students are responsible for work missed and for completing all work before the next class meeting. Students are responsible for participating in all oral drills and for taking all exams.
