### PREREQUISITE: DNC 072

#### COURSE DESCRIPTION

Intermediate level Native Hawaiian dance, Hula, to include oli- chanting.

### 1. <u>COURSE GOAL</u>

- 1.1 Study Native Hawaiian Dance, H*ula*: terminology in `*Ōlelo Hawai*`*i* Hawaiian, intermediate steps, storytelling through body movement and *kaona* (figurative interpretation of words)
- 1.2 Continued exposure to *`Olelo Hawai`i-* Hawaiian language
- 1.3 Retell the history and traditions of *Hula*
- 1.4 Increased body control in space

#### 2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 Demonstrate understanding of the terminology in *`Olelo Hawai`i-* Hawaiian for basic feet and hand movements
- 2.2 Practice and perform feet and hand movements of H*ula* within the context of a choreographed dance
- 2.3 Perform the choreographed dance to accompaniment
- 2.4 Describe the history of *Hula*
- 2.5 Develop elementary level understanding and correct usage of `*Ōlelo Hawai*`*i* Hawaiian language
- 2.6 Practice Hawaiian protocols associated with Hula

#### 4. <u>LEARNING ACTIVITIES</u>

- 4.1 Participation in learning basic and intermediate steps and hand gestures
- 4.2 Practicing working within small and large groups

4.3 Document *mele* and chants along with hand and foot movements within a notebook

- 5.1 Demonstration of competencies
- 5.2 Quizzes (written and demonstrative)
- 5.3 Public Dance Performance

## 6. <u>STUDENT RESPONSIBILITIES</u>
