DNC 170 DANCE EXPERIENCES FOR CHILDREN

Credit Hours: 2 Lec 1 Lab 2

PREREQUISITE: None

COURSE DESCRIPTION

Introduction to the theory and practice of teaching a variety of dance forms to school-aged children, including but not limited to creative, folk, ballet, and jazz. Emphasizes the basic elements of dance-space, time, and energy—in the preparation of age-appropriate lesson plans. Includes community field experience to diversify experiences in dance instruction.

- 1.2 Understand developmental benchmarks and age-appropriate dance lessons and assessments
- 1.3 Learn how to incorporate other art forms and academic areas with dance

- 2.1 create dances that incorporate time, space, and energy.
- develop informal plans to teach young children in a variety of dance settings.

6. <u>STUDENT RESPONSIBILITIES</u>
