DNC 240 DANCE PRODUCTION

PREREQUISITE: NONE

COURSE DESCRIPTION

An introduction to the technology, equipment and practices of technical production as they relate to dance performances. Emphasizes developing and applying critical analysis and design aesthetic to lighting, staging and music for dance productions.

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 Classroom Assignments: Students are responsible for work missed and for completing all work before the next class meeting. Students are responsible for participating in all oral

drills and for taking all exams.
