DRN 102 Image Acquisition and Analysis

Credit Hours: 1.5 Lec 1, Lab 1

PREREQUISITE: DRN 101

COURSE DESCRIPTION

This course is designed to develop image analysis skills to create 3-D visualizations for 3-D modeling.

1. <u>COURSE GOAL</u>

Demonstrate knowledge of image acquisition and analysis from image acquired by drone.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 describe the different types of imaging systems and sensors.
- 2.2 describe the use and mounting of a gimbal on an unmanned aircraft system.
- 2.3 identify the different applications that the imagery can be used for.
- 2.4 process imagery acquired from a drone and conduct analysis of the location.
- 2.5 identify the different types of software used for image processing.
