EAP 94 Structure 4 Credit hours: 4 Lec: 4

PREREQUISITE: Passing score of C or better in ESL 93S, ESL 93B or a proficient entrance score in the ESL placement exam

COURSE DESCRIPTION

Structure 4 incorporates integrated language instruction with an emphasis on high-intermediate grammatical concepts. Students will be exposed to a variety of grammatical concepts and be given the opportunity to use these concepts manipulatively, meaningfully and communicatively.

1. <u>COURSE GOAL</u>

The goals of this course are to further the listening, speaking, reading, and writing competence of students by using advanced grammatical structures as vehicles for integrated language acquisition.

2. OUTCOMES

- 2.1 Demonstrate mastery of grammatical structures previously studied by correctly applying verbs tenses, modals, comparative and superlative forms of adjective and adverbs.
- 2.2 Synthesize grammar concepts by integrating advanced writing techniques to enhance the effectiveness of written communication.
- 2.3 Recognize and classify errors like fragments, verb tense issues, and punctuation misuse.
- 2.4 Engage editing skills to revise written work for accuracy, engaging in self-editing, revising sentence structures, and applying feedback for improvement.
- 2.5 Apply grammatical structures such as past, present, future perfect and perfect progressive in active and passive verb forms in written and spoken communication.
- 2.6 Apply gerunds after special verbs and expressions and as subjects, infinitives after special verbs and expressions.
- 2.7 Identify and apply past and present real and unreal conditionals in sentence development and structure.

3. METHODS OF INSTRUCTION

- 3.1 Communicative, text-based, and task-based language teaching
- 3.2 Use of projector, wall charts, video and computers to reinforce grammar, reading, writing and oral-aural skills to present and practice the grammatical structures and topics
- 3.3 Discussions using recently acquired grammatical structures, functions and topics in pairs and in groups
- 3.4 Use of supplementary readings to reinforce recently acquired grammatical structures, functions and topics
- 3.5 Written practice of recently acquired grammatical structures, functions and topics in group, pair and individual work

4. LEARNING ACTIVITIES

4.1 Meaningful and communicative oral-aural practice of grammatical structures via discussions of chapter themes in pair and group work

- 4.2 Limited manipulative oral practice of structures via repetition, substitution and transformation drills
- 4.3 Written practice of selected structures in sentences, paragraphs note-taking and dictation in individual, pair and group work
- 4.4 Use of supplementary readings to reinforce selected grammatical structures

5. EVALUATION

- 5.1 Attendance and participation are mandatory and will be evaluated
- 5.2 Assignments will be evaluated 5.3 Students will demonstrate mastery of materials via inclass activities
- 5.4 Chapter exams, quizzes and a final will be given
- 5.5 Exams will be comprehensive in nature to include all skill areas and will reflect the integrated language approach of this course

6. STUDENT RESPONSIBILITIES
