# ECE 101 PROVIDING A HEALTHY ENVIRONMENT FOR CHILDREN IN AN EARLY CHILDHOOD PROGRAM

Credit Hours: 1 Lec <u>.5</u> Experience 1

PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Work in a child care setting or acceptance as an intern at AWC Child Development Learning Laboratory (CDLL)

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL. This course combined with ECE 103 and ECE 111 is accepted as equivalent to ECE 165.

#### COURSE DESCRIPTION

Procedures and practices designed to protect the health of young children in early childhood programs.

### 1. COURSE GOALS

- 1.1 Establish and maintain a healthy environment.
- 1.2 Maintain a commitment to professionalism.

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify the important health functions of an early childhood program and discuss the teacher's role in carrying out these functions.
- 2.2 demonstrate knowledge of basic sanitation standards in the early childhood setting and use proper methods to maintain them.
- 2.3 identify the symptoms of an ill child and implement the appropriate procedures for dealing with illness in the early childhood setting.
- 2.4 demonstrate ways to promote dental health in the early childhood program.
