ECE 103 ENSURING A SAFE ENVIRONMENT FOR CHILDREN IN AN EARLY CHILDHOOD PROGRAM

Credit Hours: 1 Lec .5 Experience 1

PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Work in a childcare setting or acceptance as an intern at AWC Child Development Learning Laboratory (CDLL)

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

This course when taken with both ECE 101 and ECE 111 is equivalent to ECE 165.

COURSE DESCRIPTION

Prepare methods and skills necessary to provide a safe environment for children in an early childhood program.

1. COURSE GOALS

- 1.1 To establish and maintain a safe environment.
- 1.2 To maintain a commitment to professionalism.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 construct and maintain a safe indoor and outdoor environment for the children in care.
- 2.2 demonstrate knowledge of the procedures for dealing with emergencies that might occur in an early childhood program.
- 2.3 identify indications of possible child abuse and neglect and the procedures to follow if child abuse of neglect is suspected.

- 5.3 Any grade below a B will not be eligible to take the National C.D.A. Credential

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
