# ECE 104 PLANNED ARRANGEMENT AND SCHEDULES

Credit Hours: 1 Lec .5 Experience 1

PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Work in a childcare setting or acceptance as an intern at AWC Child Development Learning Laboratory (CDLL).

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

#### COURSE DESCRIPTION

Methods of scheduling and lesson planning designed to meet the needs of young children in a variety of early childhood settings.

- 1.3 Maintain a commitment to professionalism.

- 2.2 identify the events and activities which should be included in the daily schedule.
- 2.3 write a daily schedule providing an appropriate balance of activities throughout the day.
- 2.4 demonstrate how to individualize activity and lesson plans to meet children's needs

#### 6. STUDENT RESPONSIBILITIES
