ECE 106 BUILDING RELATIONSHIPS WITH PARENTS Credit Hours: <u>1</u> Lec <u>.5</u> Experience <u>1</u>

PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Work in a childcare setting or acceptance as an intern at AWC Child Development Learning Laboratory (CDLL).

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

COURSE DESCRIPTION

To develop methods of effective communications and cooperation between parents and early childhood program setting.

- 1. <u>COURSE GOALS</u>
 - 1.1 Support social and emotional development and provide positive guidance between families and the early childhood setting.
 - 1.2 Establish positive and productive relationships between families and the early childhood setting.
 - 1.3 Maintain a commitment to professionalism.

2. <u>OUTCOMES</u>

Upon satisfactory completion of the course, students will be able to:

- 2.1 identify communication methods that encourage a positive relationship between parents and teachers/care givers.
- 2.2 plan an initial contact with families that will provide information about the child.
- 2.3 demonstrate a variety of ongoing contacts to build and maintain communication with families.
- 2.4 prepare answers to parent's questions and concerns in ways that are appropriate to building and maintaining a positive relationship between parents and teachers/care givers.

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course may be withdrawn by the instructor. If the student does not withdraw from the course and fails to complete the requirements of the course, the student will receive a failing grade.
