# ARIZONA WESTERN COLLEGE SYLLABUS

ECE 107 THE CHILD'S TOTAL LEARNING ENVIRONMENT

Credit Hours: 1 Lec .5 Experience 1

PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Working in a childcare setting or acceptance as an intern at AWC Child Development Learning Laboratory (CDLL).

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

#### COURSE DESCRIPTION

A study of the preschool child's prepared learning environment: indoor, outdoor and community aspects. Focus on learning centers, use of developmentally appropriate materials, routines and schedules.

# 6. STUDENT RESPONSIBILITIES
