ECE 108 GUIDANCE PRINCIPLES Credit Hours: <u>1</u> Lec <u>.5</u> Experience <u>1</u>

PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Work in a childcare setting or acceptance as an intern at AWC Child Development Learning Laboratory (CDLL).

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

COURSE DESCRIPTION

Techniques and practices that encourage children to take responsibility for their own actions within a formal group setting.

6. <u>STUDENT RESPONSIBILITIES</u>
