ECE 111 NUTRITION

Credit Hour: 1 Lec .5 Experience 1

PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Work in a childcare setting or acceptance as an intern at AWC Child Development Learning Laboratory (CDLL).

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

This course, when taken along with ECE 101 and 103 is equivalent to ECE 165.

COURSE DESCRIPTION

Planning and implementing nutrition education within Early Childhood Program.

- 2.1 demonstrate knowledge and ability to use basic nutrition principles.

- 2.3 plan and conduct mealtimes that meet the developmental needs of children.
- 2.4 formulate nutrition-related activities in a variety of curriculum areas.

- 5.2 Note: Any grade below a B will not be eligible to take the National C.D.A. Credential

6. STUDENT RESPONSIBILITIES
