COURSE DESCRIPTION

Methods of creating effective communication and cooperation with families through effectively using observation, utilizing and implementing positive guidance techniques while taking into consideration culture and diversity

- 1.2 To support social and emotional development and provide positive guidance

- 2.5 identify important elements of the culture(s) of children in the program and own personal attitude related to biases

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
