## ECE 114 UNDERSTANDING HOW CHILDREN LEARN

Credit Hours: 1 Lec .5 Experience 1

PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Work in a childcare setting or acceptance as an intern at AWC Child Development Learning Laboratory (CDLL)

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

COURSE DESCRIPTION

An overview of how young children learn.

1. COURSE GOAL

- 1.1 To establish and maintain a safe, healthy learning environment.
- 1.2 To advance physical and intellectual competence.
- 1.3 To support social and emotional development and provide positive guidance.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify the abilities children possess when they confront a learning situation.
- 2.2 explain how various activities foster the four types of learning.
- 2.3 identify learning skills, in which children develop and plan activities.
- 2.4 identify cognitive concepts that are appropriate for young children and develop activity plans for these concepts.

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course may be withdrawn by the instructor. If the student does not withdraw from the course and fails to complete the requirements of the course, the student will receive a failing grade.

- Initiating contact with a faculty member to ask a question about the academic subject studied in the course
