### ECE 117 MULTICULTURAL AND ANTI-BIAS CURRICULUM

Credit Hours: 1 Lec <u>.5</u> Experience 1

PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Work in a childcare setting or acceptance as an intern at AWC Child Development Learning Laboratory (CDLL).

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

#### COURSE DESCRIPTION

Methods to implement an anti-bias multicultural curriculum

### 1. COURSE GOALS

- 1.1 Support social and emotional development and provide positive guidance.
- 1.2 Establish positive and productive relationships with families.

## 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- define the term "anti-bias" and explain how bias influences children's development
- 2.2 identify personal attitudes related to bias and address these biases so that an anti-bias, multicultural curriculum can be successful.
- 2.3 prepare a non-sexist environment in which children can learn a positive gender identity.
- 2.4 construct experiences for children to help them understand and accept those with disabilities.
- 2.5 identify important elements of the culture(s) of children in the program

- 5.1 Grading is based on evaluation of observable competencies and completion of an implementation Plan.
- 5.2 Note: Any grade below a B will not be eligible to take the National C.D.A. Credential
