ECE 121 SCIENCE AND DISCOVERY

PREREQUISITE: ESL 93R or approved ESL placement exam COREQUISITE: Work in a childcare setting or acceptance as an intern at AWC Child Development Learning Laboratory (CDLL).

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

COURSE DESCRIPTION

Techniques for helping children increase awareness and appreciation of their natural environment.

6. <u>STUDENT RESPONSIBILITIES</u>
