ECE 125 DRAMATIC PLAY

Credit Hours: 1 Lecture .5 Experience 1

PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Work in a child care setting or acceptance as an intern at AWC Child Development Learning Laboratory (CDLL).

NOTE: All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

COURSE DESCRIPTION

Methods for offering role-playing activities for young children.

1. COURSE GOAL

- 1.1 To advance physical and intellectual competence.
- 1.2 To support social and emotional development and provide positive guidance.

Upon satisfactory completion of this course, students will be able to:

- 2.1 define dramatic play and discuss how it relates to other developmental play categories.
- 2.2 construct and maintain a housekeeping area, varying it at appropriate intervals, where children can engage in dramatic play activities.
- 2.3 use dramatic play situations and props based on cues provided by the children.
- 2.4 plan for dramatic play related to curriculum themes.

6. STUDENT RESPONSIBILITIES
