ECE 128 MUSIC AND CREATIVE MOVEMENT

Credit Hours: 1 Lec .5 Experience 1

PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Work in a childcare setting or acceptance as an intern at AWC Arizona Child Learning Laboratory (CDLL).

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

COURSE DESCRIPTION

Methods to use music and creative movement in the early childhood curriculum.

1. COURSE GOALS

- 1.1 Advance physical and intellectual competence.
- 1.2 Support social and emotional development and provide positive guidance.

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify and demonstrate the value of music and the developmental appropriateness of music activities in the early childhood curriculum.
- 2.2 compile and introduce new songs to the children, including songs from the children's cultural backgrounds.
- 2.3 organize a variety of listening experiences for the children to promote listening and phonological awareness, rhythm and creative movement and self expression.
- 2.4 construct, demonstrate and evaluate a lesson plan for music and movement in the classroom

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
