# ECE 133 DEVELOPING OBSERVATION SKILLS: INFANT/TODDLER PROGRAM Credit Hours: <u>1</u> Lec <u>.5</u> Experience <u>1</u>

### PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Working in a childcare setting or acceptance as an intern at AWC Child Development Learning Laboratory (CDLL).

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

# COURSE DESCRIPTION

Methods to effectively observe and record characteristics and developmental stages of infants and toddlers.

### 1. <u>COURSE GOALS</u>

- 1.2 Support social and emotional development and provide positive guidance.
- 1.3 Establish positive and productive relationships with families.
- 1.4 Ensure a well-run, purposeful program responsive to participant needs.

- 2.4 make an implementation plan stating how the skills and information gained through completing this module will be incorporated into their ongoing teaching.
