ECE 135 GUIDANCE AND DISCIPLINE OF INFANTS AND TODDLERS

Credit Hours: 1 Lec .5 Experience 1

PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Work in a childcare setting or acceptance as an intern at AWC Child Development Learning Laboratory (CDLL).

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

COURSE DESCRIPTION

Social and emotional development of infants and toddlers as it relates to discipline.

1. COURSE GOALS

- 1.1 Support social and emotional development and provide positive guidance.
- 1.2 Establish positive and productive relationships with families.

2. OUTCOMES

Upon completion of this course, students will be able to:

- 2.1 understand the difference between punishment and discipline.
- 2.2 apply variety of positive guidance techniques that are appropriate to children's developmental levels.

- 5.1 Grading is based on evaluation of observable competencies and completion of an implementation Plan.
- 5.2 Note: Any grade below a B will not be eligible to take the National C.D.A. Credential

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course may be withdrawn by the instructor. If the student does not withdraw from the course and fails to complete the requirements of the course, the student will receive a failing grade.
