ECE 139 ORGANIZATION OF SPACE, MATERIALS, AND EQUIPMENT FOR INFANTS AND TODDLERS

Credit Hours: 1 Lec .5 Experience 1

PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Work in a child care setting or acceptance as an intern at AWC Child Development Learning Laboratory (CDLL).

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

COURSE DESCRIPTION

Construct effective environments for infants and toddlers.

1. COURSE GOALS

- 1.1 To support social and emotional development and provide positive guidance.
- 1.2 To establish positive and productive relationships with families.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify space requirements as regulated by licensing for infants and toddlers
- 2.2 construct space to meet the needs of infants and toddlers
- 2.3 construct an outdoor space that meets the needs of infants and toddlers
- 2.4 prepare play materials so that they are easily accessible to children.
- 2.5 relate knowledge of the organization of space, materials and equipment with parents.

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
