# ARIZONA WESTERN COLLEGE SYLLABUS

#### ECE 145 CDA STUDENT TEACHING-VOCATIONAL

Credit Hours: 2 Lec 1 Experience 2

PREREQUISITE: ECE 143 with a grade of "B" or higher

COREQUISITE: Have a work-site with the age group and setting appropriate to assessment

NOTE: All students are mandated to spend at least two (2) hours per one (1) credit at the AWC Child Development Learning Laboratory (CDLL). Students must have completed 480 clock hours of experience working with children in a group setting.

#### **COURSE DESCRIPTION**

Prepares the student with direct participation in an early childhood setting. Students engage in supervised teaching of young children at a chosen site. The course is the final step in the application process for the National CDA Credential.

- 1.2 Advance physical and intellectual competence of the children in care.
- 1.3 Support social and emotional development and provide positive guidance of children in care.
- 1.4 Establish positive and productive relationships with families.
- 1.5 Ensure a well-run purposeful program responsive to participant needs.
- 1.6 To maintain a commitment to professionalism.
