ECE 153 AGES AND STAGES: THE PRESCHOOL YEARS

Credit Hours: 1 Lec .5 Experience 1

PREREQUISITE: ESL 93R or approved ESL placement exam

COREQUISITE: Working in a childcare setting or acceptance as an intern at AWC CDLL.

NOTE: TB Skin Test Immunization Record. Fingerprint Clearance Card required. All students are mandated to spend at least two (2) hours per one (1) credit at the AWC CDLL.

COURSE DESCRIPTION

Theories, trends and research in the development of the pre-school years.

1. COURSE GOALS

- 2.3 identify the thought process and language development of children ages 3 to 6.
- 2.4 define the development of children ages 3 to 6 in terms of social relationships, behavior and personality.

6. STUDENT RESPONSIBILITIES
