## COURSE DESCRIPTION

Overview of environmental factors that impact the health, safety and nutrition of infants and young children.

# 1. <u>COURSE GOALS</u>

- 1.1 Provide knowledge of the interrelationship of health, safety, and nutrition and their impact on the growth and development of children.
- 1.2 Promote understanding of healthy and safe learning environments for children.
- 1.3 Examine the legislation that influences child welfare.

# 2. <u>OUTCOMES</u>

- Upon satisfactory completion of this course, students will be able to:
- 2.1 list environmental\_factors that have positive health effects and those that have negative health effects.
- 2.2 list sources for gathering information about a child's health.
- 2.3 describe ways to make a child's environment safe.
- 2.4 identify signs of abuse and neglect.
- 2.5 develop a meal plan for a young child using the food pyramid.
- 2.6 describe nutrition education activities appropriate for young children.
- 2.7 investigate local, state and federal regulations affecting child health, safety, and nutrition.

# 6. <u>STUDENT RESPONSIBILITIES</u>
