COURSE DESCRIPTION

Development of skills that promote a positive relationship between families and teachers, or professional childcare workers.

- Establish positive and productive relationships between families and the child care setting/school by supporting social and emotional development and providing positive guidance to child and parent.
- 1.2 Act as a resource coordinator and facilitator for families, which involves helping them to express themselves and get their needs met in the school and community.
- 1.3 Communicate effectively with families on a variety of matters, whether routine or emotionally charged.
- 1.4 Recognize the similarities and differences in the responsibilities and role of the child care worker and the parents.
- 1.5 Develop an awareness of local and national efforts and organizations that affect families.
- 1.6 Understand the importance of culture when working with families and within the community
- 1.7 Develop attitudes, philosophies and practical techniques that build teacher-family relationships.
