COURSE DESCRIPTION

Overview of the methods needed for effective guidance of children.

- 1.1 Understand the hereditary and environmental factors which influence adult/child relationships.
- 1.2 Explore various guidance theories.
- 1.3 Understand concepts related to positive self-image and high self-esteem.
- 1.4 Recognize the child's behavior and how they react to different guidance techniques.

- 2.1 identify biological and environmental factors which may affect the adult/child interaction.
- 2.2 describe birth order position and how a person's birth order and developmental stage may effect individual interaction.
- 2.3 discuss the development of self-esteem and the ways to encourage which build confidence and worth in the child.
- 2.4 explain how responsibility and hidden ownership of conflicts can effect esteem development.
- 2.5 identify the goals of behavior and misbehaviors.
- 2.6 explain the components of and how to use effective discipline to promote responsibility for self.
- 2.7 describe and explain positive problem solving techniques.
