COURSE DESCRIPTION

Supervised student teaching in a pre-school setting.

1. COURSE GOALS

- 1.1 Observe professionals in the field of early education.
- 1.2 Apply course theory to childhood setting.
- 1.3 Communicate effectively with other early childhood professionals.
- 1.4 Acquire effective team member skills to enhance collaborative relationships with colleagues, other professionals, and families.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to demonstrate effective teaching skills.

3. METHODS OF INSTRUCTION

- 3.1 Observation and interview by instructor
- 3.2 Participation with children 32 hours

4. LEARNING ACTIVITIES

- 4.1 Thirty-two hours minimum of directed experience
- 4.2 Compile a log

5. EVALUATION

- 5.1 Completion of 32 hours in the early childhood setting
- 5.2 Formal observation by instructor

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled
- 6.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course.
