COURSE DESCRIPTION

Study of the National Electrical Code (NEC), including local ordinances.

1. COURSE GOAL

To gain knowledge of the NEC and local requirements.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 describe the layout and structure of the NEC and correctly utilize Article 100 (definitions).
- 2.2 explain the purpose of electrical system and equipment grounding.
- 2.3 determine the demand load and minimum ampere rating electrical system feeder circuits.
- 2.4 determine the minimum size conductor, raceway, and pull boxes.
- 2.5 explain the purpose and rating process of over current protection devices.
- 2.6 determine the minimum conductor size, maximum overload protection and type controller for Alternating Current (AC) and Direct Current (DC) Motors.
- 2.7 explain the different classes of hazardous conditions and locations.
- 2.8 describe the wiring methods and equipment.
- 2.9 discuss the various local government ordinances and amendments.
