Credit Hours: 15, 20 lec (263 hrs), 11 lab (150 hrs), 6 clin (225hrs)

PREREQUISITE: EMS 294 with a minimum grade of B

Note: There is an additional fee for this class

COURSE DESCRIPTION

The third of three modules designed to prepare the working EMT-B (Emergency Medical Technician-Basic) for certification as a Paramedic in the State of Arizona.

1. COURSE GOALS

- 1.1 Expose students to concepts of advanced pharmacology.
- 1.2 Familiarize the student with pre-hospital pediatric treatment protocols.
- 1.3 Prepare the student for certification in Pediatric Advanced Life Support by the American Heart Association.
- 1.4 Familiarize the student with obstetric, gynecological and neonatal emergencies.
- 1.5 Introduce advanced intervention techniques.
- 1.6 Prepare the student for clinical and vehicular externships.
- 1.7 Further familiarize the student with hospital documentation.
- 1.8 Introduce concepts of 12 lead electrocardiography.
- 1.9 Explore current trends in hospital research.
- 1.10 Familiarize the student with the assessment and management of trauma and burn injured patients.
- 1.11 Prepare the student for certification in paramedic level Basic Trauma Life Support by the American College of Emergency Physicians.
- 1.12 Provide students the opportunity to test for certification as paramedics by the Arizona Department of Health Services – Bureau of EMS and the National Registry of Emergency Medical Technicians.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 apply knowledge of pre-hospital medications in simulated and actual patient care.
- 2.2 assess and manage pediatric patients in simulated and actual situations.
- 2.3 perform adult and pediatric patient assessment to National Registry of Emergency Medical Technicians standards.
- 2.4 perform all paramedic skills to National Registry of Emergency Medical Technicians standards.
- 2.5 assess and manage trauma and burn patients in simulated and actual situations.
- 2.6 assess and manage patients with behavioral complaints in simulated and actual situations.
- 2.7 interpret and analyze 12 lead electrocardiography, with emphasis on detection of myocardial infarction.
- 2.8 discuss current pre-hospital research issues.
- 2.9 perform all paramedic skills to National Registry of Emergency Medical Technicians standards.

6. STUDENT RESPONSIBILITIES
