ENG 247 Chicana/o Literature/GE

Credit Hours: 3 Lec 3

PREREQUISITE: ENG 101 NOTE: ENG 102 is recommended

COURSE DESCRIPTION

This course will introduce the works of Mexican-American writers of the Southwest and explore how Chicanos have used creative writing to reflect upon and express their experiences as people of Mexican descent living within the United States. Works include poetry, fiction, and essays viewed in their relationship to American cultural heritage and to contemporary culture.

COURSE GOALS

- 1.1 To analyze contemporary Chicano drama, fiction and poetry within their cultural and historical contexts.
- 1.2 To explore the intersections of identity and region, particularly as it pertains to the US/Mexican border.
- 1.3 To create awareness of human relationships, art and an appreciation of cultural diversity.

Upon satisfactory completion of this course, students will:

- 2.1 Understand how Mexican Americans have expressed themselves through creative fiction and poetry;
- 2.2 Contextualize the historical and literary trends that influenced these writings;
- 2.3 Develop skills in literary analysis and close reading;
- 2.4 Use both primary readings as inspiration for making your own contribution to the realm of Chicana/o literature
