Credit Hours: 3 Lec 3

PREREQUISITE: Reading and writing skills in the student's native language required

COURSE DESCRIPTION

Intermediate communication skills with emphasis on oral communication and pronunciation in social situations.

1. COURSE GOAL

Develop high-novice level listening and speaking competence.

Upon satisfactory completion of this course, students will be able to:

- 2.2 describe people and places including reason clauses.
- 2.3 paraphrase when listening to and giving directions.
- 2.4 use modals when identifying preferences of living conditions, understand and produce appropriate idioms with issues related to money, weather, and food.

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
