ESL 93R READING AND WRITING 3

Credit Hours: 6 Lec: 6

PREREQUISITE: ESL 92R or 92G or a proficient entrance score on the ESL placement exam

COURSE DESCRIPTION

This course is designed to develop fluency in reading and writing for intermediate ESL students. Emphasis will be placed on improving students' vocabulary development, reading strategies and written organizational skills in paragraphs and essays using appropriate grammatical structures.

1. COURSE GOAL

To develop appropriate reading and writing skills at the intermediate level

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 apply the varying organizational patterns most commonly used in paragraphs, essays, and letters.
- 2.2 incorporate the grammatical structures and correct syntax that is appropriate to the composition topic.
- 2.3 write simple, compound and complex sentences.
- 2.4 interpret discourse containing simple, compound and complex sentences
- 2.5 use transitional signals appropriately in compositions.
- 2.6 identify errors in sentences and/or compositions.
- 2.7 correct errors in sentences and/or compositions.
- 2.8 identify and use word parts: root words, suffixes, prefixes.
- 2.9 identify and use reading strategies (skimming, scanning, main idea, inferring from context).

3. METHODS OF INSTRUCTION

- 3.1 Total Physical Response (TPR), along with the audio-lingual and natural approach
- 3.2 Use of overhead project, videos, films, newspapers, magazines, short stories, and guest speakers to introduce composition topics and provide examples for students
- 3.3 Individual conferences and group discussions
- 3.4 Peer evaluation of revision and editing processes
- 3.5 Discreet analysis of specific grammar points
- 3.6 Discreet analysis of organizational patterns in narrative, anecdotal, descriptive, expository, persuasive and argumentative essays
- 3.7 Group and pair work for role-plays and information gap exercises
- 3.8 Problem solving

- 4.1 Analysis of model compositions
- 4.2 Brainstorming
- 4.3 Free and guided writing
- 4.4 Editing & revising activities
- 4.5 Reading comprehension exercises

5. EVALUATION

- 5.1 Five or six compositions (grades are based on organization, content, grammar and mechanics)
- 5.2 At least one extended paragraph will be rewritten in a three- to five-paragraph essay format
- 5.2 Chapter exams
- 5.3 In-class work
- 5.4 Participation
- 5.5 Final exams

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
