ESL 93S STRUCTURE 3

Credit Hours: 6 Lec 6

PREREQUISITE: ESL 92S or ESL 92B, or a proficient entrance score on the ESL placement exam

COURSE DESCRIPTION

Structure 3 incorporates integrated language instruction with an emphasis on intermediate level grammatical concepts. Students will be exposed to a variety of grammatical concepts and be given the opportunity to use these concepts manipulatively, meaningfully and communicatively.

1. COURSE GOAL

The goals of this course are to further the listening, speaking, reading, and writing competence of students by having them use selected grammatical structures as vehicles for integrated language acquisition.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 form yes/no and information (WH-) questions using the following tenses/aspects: simple present, past, and future, modal auxiliaries, present + past progressive(continuous), and present perfect and present perfect progressive (continuous).
- 2.2 compare and contrast the uses of verb tenses in the following combinations: simple present vs. present progressive (continuous); simple past vs. past progressive (continuous); present perfect vs. present perfect progressive (continuous).
- 2.3 identify stative verbs as a category not used in the progressive sense (some texts discuss these as "action/non-action" verbs).
- 2.4 use comparatives, equatives and superlatives with adjectives and adverbs.
- 2.5 employ modals to express ability, ask for and grant permission, make requests, give advice, and express necessity, possibility, or probability.
- 2.6 produce correct sentences with *used to + base form of the verb* to show things that generally happened or were generally true in the past.
- 2.7 use gerunds and infinitives.

3. METHODS OF INSTRUCTION

- 3.1 Use projector, wall charts, video and computer to reinforce grammar, reading, writing and oral-aural skills to present and practice the grammar structures, functions and themes
- 3.2 Discussions using recently acquired grammatical structures, functions and themes in pairs and in groups
- 3.3 Use of supplementary readings to reinforce recently acquired grammatical structures, functions and themes
- 3.4 Written practice of recently acquired grammatical structures, functions and themes in group, pair and individual work

4. LEARNING ACTIVITIES

- 4.1 Meaningful and communicative oral-aural practice of grammatical structures via discussions of chapter themes in pair and group work
- 4.2 Limited manipulative oral practice of structures via repetition, substitution and transformation drills
- 4.3 Written practice of selected structures in sentences, paragraphs, note-taking and dictation in individual, pair and group work
- 4.4 Use of supplementary readings and online activities to reinforce selected grammar structures.
- 4.5 Application of acquired structures in meaningful contexts

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
