ESL 94A ADVANCED CONVERSATION, READING, AND VOCABULARY

PREREQUISITE: Intermediate Conversation, Reading, and Vocabulary; appropriate placement scores

COURSE DESCRIPTION

This course builds upon students' basic reading and critical thinking skills in English. Classroom activities will give students an opportunity to read, listen, speak, develop vocabulary, and collaborate in English at a more advanced level.

To develop more advanced English communication skills required for academic and professional interactions.

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
