## ARIZONA WESTERN COLLEGE SYLLABUS

## ESL 94S STRUCTURE 4 Credit Hours: 6 Lec 6

PREREQUISITE: ESL 93S or ESL 93B or a proficient entrance score on the ESL placement exam

#### COURSE DESCRIPTION

Structure 4 incorporates integrated language instruction with an emphasis on high-intermediate grammatical concepts. Students will be exposed to a variety of grammatical concepts and be given the opportunity to use these concepts manipulatively, meaningfully and communicatively.

#### 1. <u>COURSE GOAL</u>

The goals of this course are to further the listening, speaking, reading, and writing competence of students by having them use selected grammatical structures as vehicles for integrated language acquisition.

## 2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 use grammatical structures studied in previous levels: verb tenses, modals, and comparative and superlative forms of adjective and adverbs.
- 2.2 use of grammatical structures such as, past, present, and future perfect and past, present and future perfect progressive (continuous); passive verb forms; complex modals; use of gerunds after special verbs and expressions and as subjects; infinitives after special verbs and expressions; and real and unreal conditionals.
- 2.3 combine sentences and use recently acquired grammatical punctuation and structures

# 3. <u>METHODS OF INSTRUCTION</u>

- 3.1 Total Physical Response (TPR), along with the audio-lingual and natural approach
- 3.2 Use of overhead projector, wall charts, video and computers to reinforce grammar, reading, writing and oral-aural skills to present and practice the grammatical structures, functions and topics
- 3.3 Discussions using recently acquired grammatical structures, functions and topics in pairs and in groups
- 3.4 Use of supplementary readings to reinforce recently acquired grammatical structures, functions and topics
- 3.5 Written practice of recently acquired grammatical structures, functions and topics in group, pair and individual work

## 4. <u>LEARNING ACTIVITIES</u>

- 4.1 Meaningful and communicative oral-aural practice of grammatical structures via discussions of chapter themes in pair and group work
- 4.2 Limited manipulative oral practice of structures via repetition, substitution and transformation drills
- 4.3 Written practice of selected structures in sentences, paragraphs note-taking and dictation in individual, pair and group work
- 4.4 Use of supplementary readings to reinforce selected grammatical structures

## 5. <u>EVALUATION</u>

- 5.1 Attendance and participation are mandatory and will be evaluated
- 5.2 Assignments will be evaluated
- 5.3 Students will demonstrate mastery of materials via in-class activities

- 5.4 Chapter exams, quizzes and a final will be given
- 5.5 Exams will be comprehensive in nature to include all skill areas and will reflect the integrated language approach of this course

#### 6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 Classroom Assignments: Students are responsible for work missed and for completing all work before the next class meeting. Students are responsible for participating in all oral drills and for taking all exams.
- 6.3 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course will be withdrawn by the instructor. If the student does not withdraw from the course and fails to complete the requirements of the course, the student will receive a failing grade.
