NOTE: Reading and writing skills in the student's native language required

COURSE DESCRIPTION

Advanced communication skills with emphasis on oral communication and pronunciation in social situations.

1. COURSE GOAL

Develop intermediate level listening and speaking competence.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 describe personal choices employing past and present perfect tenses.
- 2.2 describe relationships and feelings using clause connectors of time, reason, and contrast.
- 2.3 give advice to personal problems using verbs and phrasal verbs followed by prepositions.
- 2.4 describe likes and dislikes while employing particular vs. general indefinite nouns.
- 2.5 understand and produce appropriate idioms with personal information.
- 2.6 discuss options using interrogative clauses as subjects and objects.
