ESL 95E EVERYDAY AMERICAN IDIOMS AND PHRASAL VERBS Credit Hours: <u>3</u> Lec <u>3</u>

PREREQUISITE: Eligibility for ESL level 3 or higher

COURSE DESCRIPTION

Integrated language instruction with an emphasis on idioms, expressions specific to American English, and cultural information and statistics on life in the United States.

1. <u>COURSE GOAL</u>

Further the listening, reading, writing, and comprehension by students of selected idioms, phrasal verbs, prepositional verbs, and phrasal-prepositional verbs as vehicles for integrated language enhancement

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate the use of newly acquired idioms, phrasal verbs, prepositional verbs, and phrasalprepositional verbs.
- 2.2 complete sentences with suitable English idioms and/or phrasal verbs, prepositional verbs, and phrasal-prepositional verbs in different tenses.
- 2.3 match idioms and phrasal verbs, prepositional verbs, and phrasal-prepositional verbs with their definitions.
- 2.4 have brief conversations using newly acquired idioms and phrasal verbs, prepositional verbs, and phrasal-prepositional verbs.
- 2.5 recognize the difference between transitive and intransitive verbs.

3. <u>METHODS OF INSTRUCTION</u>

- 3.1 Total Physical Response (TPR), along with the audio-lingual and natural approach
- 3.2 Use of written materials which demonstrate the use of idioms, phrasal verbs, prepositional verbs, and phrasal-prepositional verbs
- 3.3 Discussions using recently acquired target items
- 3.4 Written practice of recently acquired target items
- 3.5 Listening activities of recently acquired target items

4. <u>LEARNING ACTIVITIES</u>

- 4.1 Meaningful and communicative oral-aural practice of idioms and phrasal verbs via discussions, giving advice, sharing of personal information, role-plays, etc.
- 4.2 Limited manipulative oral practice of idioms and phrasal verbs via repetition, tense-changing drills, and transformational drills
- 4.3 Written practice of selected idioms in sentences, dictations, in paraphrasing reports, and composing stories
- 4.4 Use of supplementary materials to reinforce selected idioms and phrasal verbs
- 4.5 Figuring out meanings of idioms, phrasal verbs, prepositional verbs, and phrasal-prepositional verbs based on introductory context
- 4.6 Comprehension activities based on language in contexts such as greeting cards, conversation fragments, and newspaper articles

5. <u>EVALUATION</u>

- 5.1 Attendance and participation
- 5.2 Assignments
- 5.3 Activities
- 5.4 Chapter exams, quizzes, and a final

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
